SUBJECT: SECURITY CLEARANCE CERTIFICATE/NOC.

I am directed to refer to your letter dated 16th February, 2023 on the subject noted above and to convey approval of the Secretary Home to grant extension in Security Clearance Certificate/NOC in favour of Khwendo Kor Organization for the project titled "**Interest Free Loan (IFL) Programme**" in District Bannu, Khyber Pakhtunkhwa **upto 01-05-2024** on the following revised terms & conditions:-

- a. The NGO will not enlist the unregistered NGOs as its partners in Khyber Pakhtunkhwa.
- b. The NGO shall not use Wireless Equipment or sensitive gadgets without valid license/permission.
- c. The NGO will work in collaboration/coordination with concerned Deputy Commissioner/Local Government.
- d. All instructions/orders/rules with regard to NGOs shall be obeyed/adhered to and Annual/Quarterly activities report be furnished by the NGO regularly.
- e. The NGO shall not indulge in any illegal/immoral activity.
- f. The NGO shall respect the religious sentiments of people and shall not indulge in any kind of religious preaching or propaganda.
- g. The NGO shall refrain from photography of sensitive Government installations or mapping of any sensitive area.
- h. The NGO will not conduct any geological, seismic or similar surveys.
- i. Staff of your Organization is NOT allowed to work in areas/sectors other than specified in your request.
- j. Go/No go Areas be clearly spelled out to the staff of your Organization.
- k. proper security protection may be ensured during stay and also field visits.
- l. Staff/persons shall not visit restricted areas/installations.
- m. Visit to areas located in close proximity to Newly Merged Frontier Regions (FR) with the District concerned, if any, is NOT allowed.
- n. No Camera/surveillance/survey/wireless/intelligence gathering equipment of any kind be carried on person/in the vehicles/luggage etc
- o. This NOC will be valid (**Upto 01-05-2024**) unless withdrawn/cancelled earlier.
