Subject: **APPROVAL OF ADDITIONAL PROJECT "ALLOWED TO WORK" STATUS
IN RESPECT OF M/S KHWENDO KOR (NGO)**


I am directed to convey the approval of the Secretary, SAFRON for grant of "Allowed-to-Work" status for Additional Project in respect of M/s Khwendo Kor to work for the additional project titled "Afghan Women Social and Economic Empowerment (AWSEE)" located in "KPK" valid upto 31st December, 2024 as per following conditions:-

- i. The organization will strictly work within the ambit of MoU and does not take any other project.
- ii. The Allowed-to-Work status/permission will be only for welfare work for Afghan refugees (provision of facilities on gratis basis); as well as for work in connection with RAHA Program (Hosting Areas component).
- iii. The NGO will not enlist the unregistered NGOs as its members in Pakistan.
- iv. The period of "Allowed-to-Work" is extendable subject to abidance by all government directives/policies/instructions and laws regarding NGOs in Pakistan with satisfactory performance and sound reputation, to be verified by the Scrutiny Committee after expiry of the Allowed-to-Work period.
- v. The NGO will not use Wireless Equipment without valid license/permission.
- vi. The NGO will not employ foreign nationals without permission of the government.
- vii. The NGO will work in collaboration and coordination with concerned CARs and CCAR and inform them also before initiating any work for welfare of Afghan Refugees.
- viii. The NGO will furnish quarterly and annual activities reports regularly in respect of welfare work for Afghan Refugees/Hosting Areas Component of RAHA Program to Ministry of SAFRON.
- ix. The status of Allowed-to-Work will be withdrawn in the event of failure to abide by the above conditions.
- x. Provide updated lists of foreign/local hired staff and activities/progress report, funds received from abroad and its expenditure in Pakistan to this Ministry on six monthly bases.

- xi. Allowed to work status can be revoked at any time if the organization does not adhere to the prescribed conditions and it is found involved in activities which violate the policies of the Government.
