

2 Days Provincial Consultative Workshop Assignment (TA) Terms of Reference (ToRs)

1. INTRODUCTION AND BACKGROUND

Khwendo Kor (KK) is a woman led women organization striving for women empowerment in Pakistan since 1993 and is registered under the Societies Registration Act 1860. Since inception, girls' education, Civil Rights, Women Economic Empowerment, Women Political Participation and addressing GBV issues remained the main focus/programs of the organization.

Currently, KK has been awarded a consulting service contract to prevent and address Gender-Based Violence (GBV), Sexual Exploitation and Abuse (SEA), and Sexual Harassment (SH) under the Khyber Pakhtunkhwa Rural Accessibility Project (KP-RAP) by the Project Implementation Unit (PIU) of the Communication and Works Department (C&W) of the Government of Khyber Pakhtunkhwa. KK will execute the consultancy through various components and activities for 2 years (2024-2025) which will include the establishment of effective referral pathways and frameworks that will engage stakeholders and build their capacities on GBV, SEA and SH through provincial trainings and consultative workshops. The Grievance Redressal Committees (GRC) are formed in 23 districts of KP will ensure that the Risk of GBV, SEA and SH are minimized and addressed.

2. PURPOSE OF THE -TERM TRAINING ASSIGNMENT.

The key purpose of the assignment is to build the capacity of relevant stakeholders to understand the GBV, SEA and SH reporting mechanism and play important role to enhance the existing reporting mechanisms notified by Communication and Works Department Project Implementation Unit (PIU), GoKP. The engagement of key stakeholders should provide the recommendations to sustain the referral services under defined GBV case management protocols. All the targeted groups should be aware of the concerned protocols.

KK is seeking to hire the services of a potential consulting firm/organization having its legal status in Pakistan under any relevant prevalent government law. The potential consulting concern having its expertise in providing training on GBV trainings and strengthening the referral pathways for GBV, SEA, SH, and Violence against Children (VAC) to help manage GBV risks in the 23 selected districts of the KP-RAP project sites. The selected short-term consultant should have extensive experience in raising awareness about GBV, conducting training sessions, and engaging with various stakeholders including government officials to address GBV issues effectively. They should be able to develop training modules, and materials, and ensure the delivery to generate the action plans as result of workshop that lead towards the sustainability of project. The consult must be able to undertake the assignment within the agreed period and budget. The selected short-term training consultant

will be responsible for producing training manuals, reports, and to deliver the training sessions as agreed under the ambit of consultancy deliverables.

3. **SCOPE OF WORK**

- 3.1. KK is looking for the services of organization and Individuals to conduct 2 days provincial training under KK supporting Prevention and Response of GBV, SEA and SH risk Mitigations and Measures under the Khyber Pakhtunkhwa Rural Accessibility Program. This consultancy will involve:
- 3.1.1. Development of training content based on the provided theme including the sensitizing selected groups on GBV, SEA and SH, GBV action plans for referral pathways and reporting mechanism at district and provincial levels.
- 3.1.2. Prepare a training report with action plans and recommendations for sustainability of referral pathways.

The above services aimed to mitigate and prevent SEA/SH risks related to project components, tailored to the local context, including support in developing and implementing necessary protocols and mechanisms. The objective of this consultancy is to address GBV at all levels, improve support for survivors, enhance case management, and prevent future incidents. The selected consultant will develop methodologies, materials including module for the entire proposed consultative workshop that is planned on last week of July 2025. The selected short-term consultant will be responsible for the execution and management of the approved workshop plan under agreed budget for the assignment.

3.2. Role of the short-term consulting organization/Individual:

- 3.2.1. Develop workshop module and PPT submit to KK for approval.
- 3.2.2. Submit training materials for approval to KK.
- 3.2.3. Conduct pretesting workshops, and proceed with agreed training agenda.
- 3.2.4. Adhere to human rights principles, contain non-harmful content, and include GBV mitigation strategies tailored to project-specific risks.
- 3.2.5. Ensure stakeholders are well-informed about GBV protocols, Codes of Conduct (COC), SEA/SH guidelines, and referral pathways for managing GBV cases.
- 3.2.6. Submit workshop report and action plans to KK for approval.

3.3. Geographical Location:

Islamabad, Highland Country Club and Resort.

3.4. Task Duration and Workshop Dates:

 $15^{th} - 31^{st}$ July is the overall duration, however the consultative workshop is planned on 25^{th} and 26^{th} of July 2025.

- 5.5. Provision of at least 3 reference letters from GoP and any other donor/organization with whom they have completed the similar thematic assignments.
- 5.6. Have proper bank account for payment against the completed deliverable.
